Rules of Conduct

- 1. Participants must not participate in any police action unless asked to do so by the officer. Participants are solely observers.
- 2. Business/professional attire shall be worn. No t-shirts with graphics or offensive markings. The supervising officer has sole discretion to accept ride along based on appearance.
- 3. The participant shall not carry weapons or have any electronic recording devices.
- 4. All activities and information observed, overheard, obtained or in any resulting from the participant's involvement with this Ride-Along Program shall be treated by the participant as CONFIDENTIAL.
- 5. Ride along participants may accompany officer into private residences or into other places not readily open to the public when the owner/resident or other person in control of the premises expressly consents to the ride-along participant's entry.
- 6. Ride-along participants may not exit the squad car during a traffic stop prior to the occupants being secured, unless it is necessary to insure their safety or approved by the supervising Officer.
- 7. The participant must read and sign the host agency's "Agreement Assuming Risk of Injury or Damage, Waiver and Release of Claims and Indemnity Agreement."
- 8. The participant's ride may be temporarily or permanently terminated at the sole discretion of a police officer, and the participant shall immediately comply.
- 9. Certified officers from other agencies may not wear their agency uniform or firearm and must comply with the other standards of attire and grooming for observers.
- 10. Participants in the ride-along program are guests of the Police Department and must conduct themselves in an appropriately responsible manner.
- 11. Observers will not:
 - a. Be under the influence of alcohol or have the odor of an alcoholic beverage on their breath.
 - b. Use profane or abusive language or behave in any manner that would provoke or escalate tensions.
 - c. Enter into any investigation or converse with any citizen, witness, or prisoner, concerning a police incident or investigation.
 - d. Make known to unauthorized persons the identity of persons arrested, detained, confined in jail, or suspected of any offense.
 - e. Operate or use any police equipment or vehicle or any police item, except in case of emergency or when requested to do so by a police officer.
