### Archery Range Rules

1. Targets must be set up a minimum of 50 feet from CTH T and must be placed along the southern hillside of the range. All other DNR Regulations regarding bow safety and transport must be followed.
2. Clean up when you are done. You bring it into the range, you take it out. Garbage cans will not be provided.
3. Firearms are not allowed. This is not a firearms range.
4. Everyone using the range must have their permit with them and are subject to being checked by law enforcement.
5. Range is open from dawn to dusk.
6. Hunting on the range is prohibited

### Barneveld Village Ordinance 9.01 Discharge of firearms and other dangerous weapons

Restriction on use of firearms. Firearms shall only be discharged within the village only in compliance with the following standards:

1. Law enforcement personnel in the performance of their duties
2. All other persons shall obtain a written permit from the Village Police Department before discharging a firearm.

#### Permit Required

1. No person may discharge any firearms in the Village of Barneveld without obtaining a written permit from the Chief of Police or his authorized agent, and written permission by the landowner. Landowner property must be greater than 2 acres or is a approved game farm.
2. No firearms shall be discharged within 50 feet of any street, road or highway, nor within 300 feet of another person's dwelling in the village.
3. A permit from the Chief of Police shall be required for the hunting or trapping of wild animals or birds causing damage to growing agricultural crops, or creating a public safety nuisance, as determined by the Department of Natural Resources. Any one engaged in this activity shall comply with all state statutes and Rules.

#### Permit Application

1. An application shall be submitted to the Police Department by a person wishing to discharge a firearm in the village upon the forms provided by the Police Department.
